2010 Vendor Fees / Space Rental Cost Structure

Registration Fee -- Each vendor must pay an upfront fee of \$40.00 to reserve their space at the market. This fee is non-refundable, but will be applied to the vendors overall space rental fee if they exceed the maximum seasonal charge as outlined below.

Weekly Space Rental Fee -- 10% of sales dollars for that market day, with a maximum fee of \$20 per week.

Weekly Check Out Process -- Before leaving the market each Saturday, please remit your rental fee payment and sales information to a market member at the Farmers' Market Booth.

Maximum Season Fee -- The maximum fee to be paid by a vendor for the season is \$300. No additional weekly rental fees will be collected once a vendor has paid a total of \$300, including the initial Registration Fee.

Vendor has read and understands the 2010 Rules for the Tippecanoe Farmers' Market and is bound by the terms and conditions outlined in them. Vendors are responsible for the quality and safety of what they sell.
